I. OPEN SESSION

Minutes

Principal Sargent called the meeting to order at approximately 3:25 p.m.

Principal Sargent shared that the senior class hosted a dance for Two Rivers Elementary School.

Principal Sargent shared with the council that the Winter NWEA testing session was a success. All students have completed their testing sessions.

Principal Sargent shared that Performing Arts classes performed at two recitals on 12/7 & 12/8.

Principal Sargent shared that LGA is now a full CIF member and are now playoff eligible.

Principal Sargent shared that winter sports are starting up. Students and staff are excited about the upcoming season.

V. REPORTS AND PRESENTATIONS

Minutes

Principal Sargent presented a Read 180 report which showed Quarter 1 student results for two different classes.

Class 1: 4 of 24 improved in reading and language. 10 of 24 improved reading or language. 15 of 24 increased lexile. Of the students whose lexile increased, there was a 105 point average increase from the beginning of Quarter 1 to the end of Quarter 1.

Class 2-6 of 17 improved in reading and language. 9 of 17 improved reading or language. 6 of 17 increased lexile. Of the students whose lexile increased, there was a 129 point average increase from the beginning of Quarter 1 to the end of Quarter 1.
