- a. Mrs. Rodriguez shared that the LGA Talent Show was held on January 31st. The event was well attended, there were a wide variety of acts and strong staff presence. A junior student, Melissa Harris, won the evening by writing and performing an original song.
- b. Mrs. Rodriguez stated that 34 out of 60 seniors have received early acceptance letters from colleges. That is 50% of our graduating class. Most early acceptances are from CSUs, and students are waiting to hear back from UCs.
- c. Mr. Daniel Meyer shared that both varsity basketball teams won league. He also stated that it was the first time that LGA hosted a basketball playoff at LGA. He added that the athletic teams are looking forward to the sports banquet in May.

He has been working with NUSD Maintenance on the issue, and hopes to have a plan in place soon to fix all necessary areas of concern. Angela Herrera added that she is aware of the issues and that she has also been in communication with Maintenance.

Andrea Rodriguez shared projected enrollment numbers for 2019-2020. For middle school, all grade levels will be at 150 per grade level. She stated that LGA started the year at 110 for 9th, and current enrollment is at 100. Hoping to be at 120 for incoming 9th graders. The projected enrollment total is 829 for 2019-2020.

Andrea Rodriguez shared information about replacing the current curtains that are used on the stage in the Multipurpose room. She said that she has been working with the performing arts teachers to gather quotes for the curtains.
