Principal Fitzgerald shared an update about the Class of 2019 College Admissions. To date, 111 seniors have been accepted to a CSU. There have been 18 total admissions into UCs. There have been 12 students accepted to out of state and/or private colleges. Lastly, there have been 12 students accepted into community colleges, and 86% of our seniors have completed the FAFSA application.

Principal Fitzgerald shared information about the Quarter 3 Academic Assembly. The assembly is held to celebrate those students that high achieved GPAs above a 3.0 or have increased their GPAs by .5 or higher over the course of the quarter. We also celebrate perfect attendance and give medals to those students nominated by their teachers. These students consistently show PRIDE (Purpose, Results, Innovation, Determination, and Empathy) on campus.

Mrs. Rodriguez shared information about LGA's 5th Annual Multicultural Night. There was a great turnout that included parents, community members, students, and staff. The event celebrated many cultures by offering traditional food and/or beverages, performances, and music.
