Minutes

Principal Fitzgerald presented the findings of the WASC visiting committee. He stated that on Monday, February 1st, the WASC visiting committee began a virtual mid-cycle visit, which lasted two days. He added that during their two-day visit the visiting committee interviewed a variety of different stakeholder groups including administration, teachers, counselors, parents, students, and district officials. He added that LGA's building team provided a comprehensive presentation outlining how LGA has addressed the identified critical areas of follow-up and made progress in the implementation of our Action Plan. Upon completion of the visit, LGA Administration was provided a report of the visiting committee's findings that included areas of strength and additional areas of follow-up to be addressed over the next three years.
