Recommended Motion:

The council is asked to ratify the Inform 2 Inspire consulting contract and purchase order which includes the coordination of the 2022 LCAP for Leroy Greene Academy.

b. Approve Purchase of Chromebooks from STS Education for Students
Technology Refresh through NUSD CMAS Piggyback Contract

Recommended Motion:

The Board is asked to approve the purchase of Chromebooks from STS Education for the NUSD Student Technology Refresh Program through a CMAS (California Multiple Awards Schedules) Piggyback Contract.

Rationale:

In alignment with the NUSD established student technology refresh cycles, 400 Chromebooks will be purchased for the remainder of the 2021-2022 and the beginning of the 2022-23 school years. These Chromebooks will provide educational technology for students that aides in regular and substantive

educational interactions between students and classroom teachers. Pandemic Relief Funds will be used for this purchase. The attached NUSD CMAS (California Multiple Award Schedules) base agreement with STS Education provides for the purchase and warranty of the Chromebooks through this piggyback contract. The attached quote includes the purchase of Chromebooks, educational licenses, white glove service, warranties and equipment for a total contract amount of \$123,565.00 (One hundred twenty three thousand, five hundred sixty five dollars).

c. Approve Purchase of MacBook Airs, iPads, Apple Pencils for Student Technology Refresh Through Piggyback Contract with Apple Inc

Recommended Motion:

The Council is asked to approve the purchase of MacBooks Airs, iPad Pros, and Apple Pencils for student technology refresh through a piggyback contract with Apple Inc.

Rationale:

In alignment with the NUSD established student technology refresh cycles, 40 MacBook Pros, 40 iPad Pros, and 40 Apple Pencils will be purchased for the remainder of the 2021-2022. These MacBooks will provide educational technology for students that aids in regular and substantive educational interactions between students and classroom teachers. Pandemic Relief Funds will be used for this purchase. Apple Inc. offers educational pricing through piggyback contracts secured by other school districts. Through this competitive pricing, LGA will purchase all items listed in the quote attached for One Hundred Forty Four Thousand Six Hundred Nine Dollars and Fifty Cents (\$144,609.50).
