b. Q2 Academic Assembly

Minutes

Principal Rodriguez shared with the council about the Q2 Academic Assembly. He added that this quarter we changed the logistics up by splitting different grade levels to leave more time to recognize students. Principal Rodriguez shared that 399 students were recognized overall for their GPAs. Mr. Rodriguez also added that

LGA is finishing up a 20-day attendance campaign. He said that we have seen an improvement in attendance numbers and that students are being recognized daily for their attendance accomplishments.

VI. PRESENTATIONS

a. Mid-Year School Update

Minutes

Principal Rodriguez reviewed the Leroy Greene Academy 2022 CA School Dashboard Summary. He opened the presentation by sharing the purpose of the CA Dashboard Summary. The presentation included slides about Academic Performance, Chronic Absenteeism, English Learner Progress, Graduation Rate, and Suspension Rate.

Principal Rodriguez shared that the past few years LGA has struggled with chronic absenteeism and a high suspension rate. He also mentioned that the CA School Dashboard includes absenteeism for grade levels 6-8 only. He added that the staff have plans in place to improve attendance and campus culture. He stated that there are programs that have been purchased such as IXL, and Amira for EL students. He also shared that LGA has rolled out Saturday Academies where it provides students to work with math teachers to improve their grades and get back on track. He said that messaging was sent out to the parents individually via Infinite Campus messenger and hard copy letters were also mailed home to invite students to join Saturday Academy.

Council Member Angela Herrera asked if there were plans to share the Saturday Academy data out to families? She stated that some parents might benefit from the school sharing it out.

Principal Rodriguez responded that he has shared information with the families of the students that attended the Saturday Academy sessions. He added that he would work with his team to share out the data to families.

Council Member Amy Adams stated that as a parent it is encouraging to hear about the data so that it shows how students benefit from attending.

Council Member Jayme Richards stated that her high school student benefited from attending the Saturday Academy and agreed that messaging out would be great.

Council members engaged in discussion regarding the suspension rate slide.

Principal Rodriguez shared that he is working with the LGA's Coordinating of

Service Team (COST) which includes the counselors, Melissa Montes (LGA Social Worker), School Resource Office Lewis, and Admin team. He added that the COST Team is thinking outside of the box to address areas such as chronic absenteeism and suspension rates.

Principal Rodriguez shared that he is proud of the English Learner (EL) students and all of their hard work. He added that quite a few EL students will be redesignated next year.

Principal Rodriguez shared that this week was School Counselors week. He explained that this week they showed appreciation for our LGA Counselng staff which includes Curtis Cole, Mailee Lee, and Carolyn Walker. He added that the team is critical to our students and that they are very much appreciated by the staff, students, and community.

Council members engaged in discussion regarding how LGA compares to similar schools in California.

Council Member Angela Herrera asked where the comparison data came from?

Principal Rodriguez shared that LGA is consulting with Dr. Joel Rabin on the LGA Local Control and Accountability Plan. Dr. Rabin collected the comparison data that is shown on the slide.

Council Member William Young suggested that LGA reach out to schools comparable to LGA to see what they are doing to address areas reported on the CA School Dashboard.

Principal Rodriguez agreed with Mr. Young and said that his team will reach out to those school listed.

Technology Refresh through CMAS Piggyback Contract

In alignment with the NUSD established student technology refresh cycles, another set of 400 Chromebooks will be purchased during this school year. These Chromebooks will provide educational technology for students that aides in regular and substantive educational interactions between students and classroom teachers. Learning Recovery Funds will be used for this purchase.

The attached CMAS (California Multiple Award Schedules) base agreement with CDW-G provides for the purchase and warranty of the Chromebooks through this piggyback contract. The attached quote includes the purchase of Chromebooks, educational licenses, white-glove service, warranties and equipment for a total contract amount of One Hundred Fourteen Thousand Five Hundred Thirty-Nine Dollars and Five Cents (\$114,539.05).
